RESOLUTION NO. 2019 - 1

RESOLUTION DECLARING NECESSITY AND EXPEDIENCY FOR ISSUANCE OF GENERAL OBLIGATION SCHOOL BONDS, CALLING AN ELECTION THEREFORE AND HIRING PROFESSIONALS IN CONNECTION THEREWITH.

BE IT RESOLVED by the School Board of Rapid City Area School District 51-4, Meade and Pennington Counties, South Dakota, as follows:

- 1. <u>Declaration of Necessity</u>. It is hereby found, determined and declared that it is necessary and expedient for this School District to borrow money by issuing its general obligation school bonds in an amount not exceeding \$189,553,000 payable from 1 and not to exceed 25 years from date of issuance, bearing interest payable at such times and at such rate or rates as may be determined by the School Board, to fund construction of three elementary schools, one middle school, a Fine Arts wing, student counseling and services center, Pathways related updates, additions and renovations to existing school facilities, deferred maintenance and other school district improvements, safety and security improvements, furnishing and equipping the same and financing costs of issuance, if so approved by the voters.
- <u>Election.</u> The question of authorizing the issuance of such bonds shall be submitted to the qualified electors of the District at a bond election which is to be held on the <u>25th</u> day of <u>February</u>, 2020 between the hours of 7:00 o'clock a.m. and 7:00 o'clock p.m. The question shall be in substantially the following form:

SHALL THE RAPID CITY AREA SCHOOL DISTRICT 51-4, MEADE AND PENNINGTON COUNTIES, SOUTH DAKOTA, ISSUE ITS NEGOTIABLE GENERAL OBLIGATION SCHOOL BONDS IN A PRINCIPAL AMOUNT NOT EXCEEDING \$189,553,000, ISSUED IN ONE OR MORE SERIES, ISSUED ON ONE OR MORE DATES, BEARING INTEREST AT SUCH RATES AS MAY BE DETERMINED BY THE SCHOOL BOARD, PAYABLE AND MATURING FROM 1 AND NOT TO EXCEED 25 YEARS AFTER THE DATE OF ISSUANCE, FOR THE FOR THE PURPOSE OF FINANCING THE CONSTRUCTION OF THREE ELEMENTARY SCHOOLS, ONE MIDDLE SCHOOL, A FINE ARTS WING, STUDENT COUNSELING AND SERVICES CENTER, PATHWAYS RELATED UPDATES, ADDITIONS AND RENOVATIONS TO EXISTING SCHOOL FACILITIES, DEFERRED MAINTENANCE AND OTHER SCHOOL DISTRICT IMPROVEMENTS, SAFETY AND SECURITY IMPROVEMENTS, FURNISHING AND EQUIPPING THE SAME, AND FINANCING COSTS OF ISSUANCE?

SHALL THE ABOVE PROPOSITION BE APPROVED AND THE BONDS ISSUED?

- 3. <u>Polling places and Judges</u>. Polling places and judges and clerks for said election shall be selected according to South Dakota Law.
- 4. <u>Voter Registration Deadline</u>. The Business Manager is hereby authorized and directed to give notice of voter registration and deadline therefore, as required by law. The deadline for voter registration shall not be less than fifteen (15) days prior to the election. The Business Manager shall give notice of the availability of registration officials and state when registration will be terminated and the effect of a failure to have registered. Such notice shall be published in official newspapers of the District at least once each week for (2) two consecutive weeks, the last publication to be not less than (10) ten nor more than (15) fifteen days before the deadline for registration.
- 5. <u>Notice of Election</u>. The Business Manager is hereby authorized and directed to give notice of school bond election, said notice to be published in the official newspaper for the District, once each week for two (2) successive weeks before said date of election. The second notice shall be published not less than four (4) days nor more than ten (10) days before the election.
- 6. <u>Ballots.</u> The Business Manager is authorized and directed to cause printed ballots to be prepared for use at said election in substantially the form on file with the Business Manager and to publish with the second notice of election.
- <u>Canvass.</u> Said election shall be held and conducted and the votes cast thereat shall be counted, certified and canvassed according to law, and this Board shall meet at the regular meeting room in Rapid City, South Dakota, in the District for the purpose of canvassing the results within six (6) days of the election.
- 8. <u>Hiring of Professionals.</u> Meierhenry Sargent LLP of Rapid City, South Dakota is hereby designated as bond counsel for this issue. Dougherty & Company LLC is hereby designated as the Municipal Advisor. The President and Business Manager are authorized to execute such documents as are necessary to carry out the intent of this paragraph.
- 9. <u>Authorization of Officers.</u> The Superintendent, School Board President and Business Manager are authorized to sign any acknowledgement, certificates or documents required by Underwriter in connection with the Bonds.


